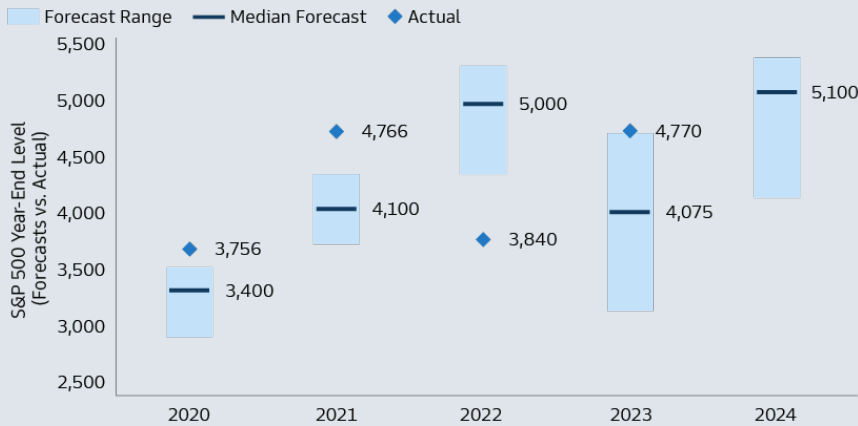

EQUITIES

Price targets are a popular exercise in communicating a firm's equity views, but index returns can be difficult to predict in practice. Over the past four years, the average delta between the median S&P 500 forecast at the beginning of a year versus the level that the S&P 500 finished said year was 17 percentage points. A strong start to 2024 has left the S&P 500 trading above most estimates, but we believe risks skew to the upside for the remainder of the year.

MARKET SUMMARY

GLOBAL EQUITIES: US equities rose in a week with little macro data as S&P 500 earnings continued to surpass consensus expectations. Ultimately, the S&P 500 finished last week 1.89% higher as 1Q 2024 blended earnings growth was positive for the fifth consecutive quarter and 5.4% year-over-year, the highest earnings growth for the index since 2Q 2022. Outside the US, the STOXX 600 and FTSE 100 finished last week 3.18% and 2.76% higher, respectively, both notching new all-time highs.

COMMODITIES: Oil prices declined last week before recovering losses on the back of cease-fire talks in the Middle East temporarily stalling. WTI and Brent crude finished slightly higher at \$78.26 and \$82.79/bbl, respectively, on a report that crude inventories in the US declined by over one million barrels. Meanwhile, gold prices rose last week to \$2397.70/troy oz.

FIXED INCOME: US sovereign yields were flat last week as the Fed's Senior Loan Officer Opinion Survey revealed that while lending standards tightened, banks were more willing to lend to consumers in 1Q 2024 relative to the prior quarter. The 2-Year and 10-Year US Treasury Yields ended at 4.87% and 4.50%, respectively. Across the pond, the 10-Year UK Gilt yield fell to 4.17% as the Bank of England held rates steady at its policy meeting but signaled that cuts were on the horizon.

FX: The US dollar modestly strengthened against a basket of currencies last week despite initial jobless claims printing at a nine-month high and consumer sentiment registering well below consensus expectations. Ultimately, the US dollar index ended last week 0.27% higher. Elsewhere, the euro and pound sterling rose to \$1.0774 and fell to \$1.2527, respectively, with the former climbing on above-consensus services data.

ECONOMIC SUMMARY

MONETARY POLICY: The Fed's April 2024 Senior Loan Officer Opinion Survey indicated that standards for commercial and industrial loans tightened at a similar pace to the quarter prior. Encouragingly on the household side, banks' willingness to lend to consumers improved substantially. In the UK, members of the Monetary Policy Committee voted 7-2 to hold the bank rate at 5.25%. The Bank of England (BoE) now expects inflation to fall to 1.9% by 2Q 2026, below its previous projection. Our colleagues in Global Investment Research (GIR) continue to expect the BoE to cut in June but believe risks skew to a later start to the cutting cycle should wage growth and services inflation remain elevated.

LABOR: Initial jobless claims in the US increased to 231k in the week ended May 4, the highest level since August 2023. The above-consensus print was in part due to an uptick in jobless claims in New York, California, and Indiana.

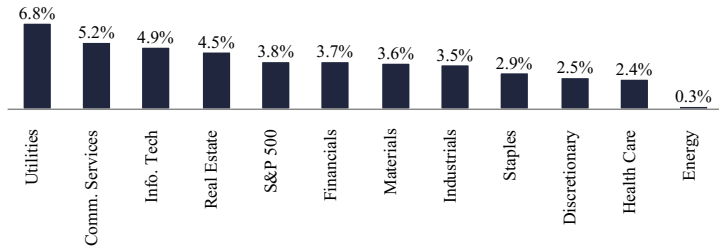
GROWTH: In the UK, 1Q GDP growth registered at 0.6%, above consensus expectations of 0.4%, lifting the economy out of the technical recession experienced in the latter half of last year. On this note, our colleagues in GIR have raised their 2024 full-year growth forecast to 0.8% (from 0.6% previously), above consensus of 0.3%.

SENTIMENT: The University of Michigan's index of consumer sentiment declined to 66.5 in the preliminary reading, the survey's lowest print this year. Additionally, inflation expectations for both the short and long term increased to 3.5% year-over-year and 3.1% year-over-year, respectively. The above-consensus print reflected higher gasoline prices and high inflation thus far in 2024, in our view.

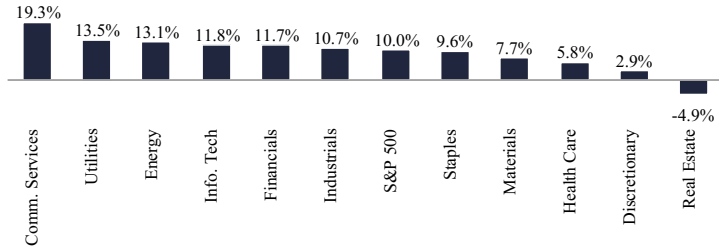

MONTH-TO-DATE, AS OF 05/10/24

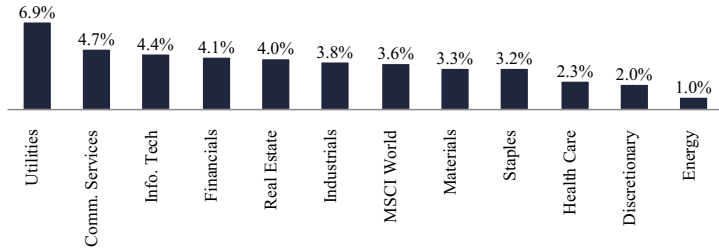


YEAR-TO-DATE, AS OF 05/10/24

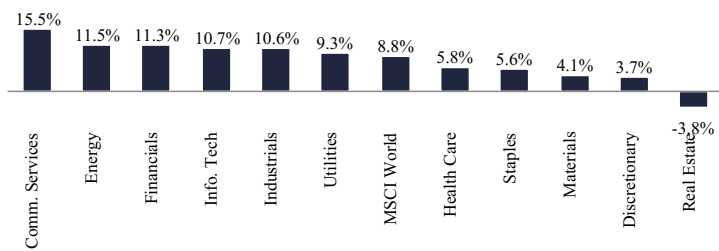


MSCI WORLD INDEX SECTOR RETURNS

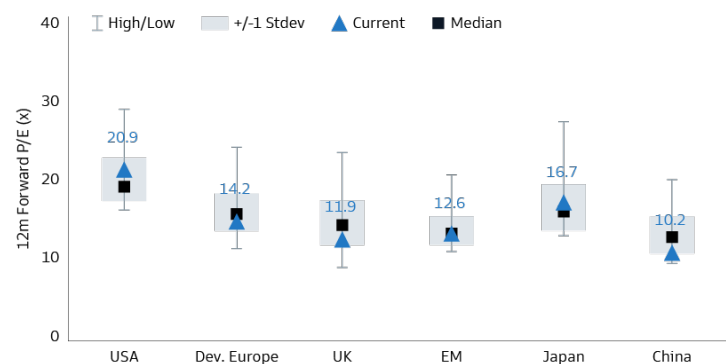
